# Terms & Conditions

## Confirmation

Cross Keys Hotel must receive a minimum deposit of \$100 and a signed copy of the booking agreement within 14 days of the tentative reservation to confirm.

## Cancellations

All cancellations must be made in writing. In the event of a function being cancelled, the following conditions will apply:

7 or more days prior to the event – the cancellation fee will be 50% of the deposit value of the function.

7 days prior to the event – the cancellation fee will be 100% of the deposit value of the function.

## Payments

Full payment of the food component must be paid 7 days prior to the event. Beverages on consumption or tab must be paid in full on completion of the function. Methods of payment include, cash, company cheque, credit card or eftpos.

## Final Attendance

A guaranteed minimum number of guests attending the function is required 7 days prior to the event for catering and billing purposes. This will be the minimum number charged for.

## Prices

All prices are current at the time of quotation but may be subject to change. All prices are G.S.T. inclusive.

## Pre Function Details

Menu selection must be made at 7 days prior to your event.

Table plans and seating arrangements must be presented one week prior to your event.

## Responsibility
